

DAVID'S BRIDAL WEDDING DRESS INSTA-GIVEAWAY
OFFICIAL RULES

SPONSOR. This David's Bridal Wedding Dress Insta-Giveaway ("Sweepstakes") is sponsored by David's Bridal, LLC, 1001 Washington Street, Conshohocken, Pennsylvania, 19428 ("Sponsor"). The Sweepstakes is in no way sponsored, endorsed or administered by, or in association with, Instagram.

SWEEPSTAKES PERIOD. The Sweepstakes begins at 10 am Eastern Time ("ET"), August 27, 2020 and ends at 11:59 pm ET September 25, 2020 ("Sweepstakes Period"). All Entries must be submitted and received within the Sweepstakes Period to be valid and eligible for the drawing.

PRIZE; ODDS. On or about September 28, 2020, Sponsor will randomly select one (1) winner ("Winner") of one (1) \$1,200 David's Bridal gift card ("Prize"). David's Bridal gift cards are good for in-store purchases only, and cannot be used for internet purchases. Not redeemable for cash, except where required by law.
