

DAVID'S BRIDAL AND THE BOUQS CO. WEDDING FLOWERS INSTA-GIVEAWAY
OFFICIAL RULES

All entries must be received within the Sweepstakes Period to be eligible to win the Prize.

PRIZE; ODDS. On or about September 28, 2020, Sponsor will randomly select one (1) winner ("Winner") of one (1) The Bouqs Co. 20-Piece Bridal Wedding Flower Package Prize. Approximate retail value ("ARV") \$599.
